Remarks:

1. Premium rates are valid from April 2019.

Premium rates are not guaranteed and are yearly adjustable based on the gender and attained Age of the Insured Person, room level, plan type, attachment of **PRU**Health Major and its level of coverage at the time of plan Renewal. We will determine the relevant premium rates based on several factors, such as our claims and persistency experience, medical price inflation, projected future medical costs and any applicable changes in benefit.
3. This Standard Premium Schedule does not include levy which is collected by the Insurance Authority.
4. If your premium is paid on a non-annual basis, the modal premium amount will be equal to the annual premium multiplied by the modal factor as shown below:
