## Remarks:

1. Premium rates are valid from October 2024.
2. **PRU**Health FlexiChoice Medical Plan is available for new applications and Renewals as a rider, while standalone plan is only available for Renewals.
3. Premium rates are not guaranteed and are yearly adjustable based on the gender and attained Age of the Insured Person, room level, plan type, attachment of **PRU**Health Major and its level of coverage at the time of plan Renewal. We will determine the relevant premium rates on a Portfolio basis based on several factors, such as our claims and persistency experience, medical price inflation, projected future medical costs and any applicable changes in benefit.
4. This Standard Premium Schedule does not include levy which is collected by the Insurance Authority.
5. If your premium is paid on a non-annual basis, the modal premium amount will be equal to the annual premium multiplied by the modal factor as shown below:

2. 保誠靈活自主醫保計劃的附加保障適用於新申請及續保，而基本計劃只限續保。
3. 保費率並非保證不變，將按計劃續保時受保人的性別及當時實際年齡、病房級別、計劃類型以及有否附加額外醫療計劃及其保障額選項而按年調整。保費率的調整將適用於所有同一類別保單，並基於不同因素，如保誠的索償及續保經驗、醫療費用通脹、預期未來醫療費用及任何適用之保障修訂。
4. 此標準保費表並未包括由保險業監管局徵收的保費徵費。
5. 如您並非以年繳方式繳付保費，每期保費金額為年繳保費乘以下列保費形式倍數：
