The Company will send out a written notice to the Policy Holders before each end of Policy Year regarding the actual premiums payable (including Premium Loading, if applicable) and levy of the coming year.

The modal factor for a rider plan is 0.5 / 0.52 (semiannual) or 0.083334 / 0.09 (monthly), following its basic plan.
